The University is pleased to inform you that it intends to award a contract for the SB-1 1st Floor Classroom Renovation project to AJ Fistes Corporation. The three-day bid protest period will begin on Friday, August 30, 2024 and will expire at 5:00 P.M. on Wednesday, September 4, 2024.

The University has begun its internal process to award a contract to your firm for this project. In view of the foregoing, this letter should not be considered an award of the contract until a Notice to Proceed is received. Until such time, the University reserves the right to reject all bids.
